At the conclusion of each year, I set aside time to review all aspects of our firm in detail. It is report card time, where we look at and dig into our case results, our processes and systems in handling cases, our client experiences and services, and every aspect of our firm, and we look to what we can improve. It is not a simple pass or fail evaluation, but a comprehensive tear down of everything that goes into how this place runs and the service we want to provide to each and every cli-

ent and prospective client. We also look at what we have done outside of our day-to-day practice in our charitable endeavors, and where we can continue to make an impact in our community.

For 2022, we recovered over \$20 million dollars for clients. Our year-end total almost directly matches our year-end total from the year before. For a firm our size, which has approximately 25 members, this is an amazing total. The fact that we were able to achieve the same in back-to-back years, shows a consistency which is hard to achieve in this business. We also achieved this number with less overall settlements in 2022 than we had in 2023. This means that our average recovery per file actually increased. This is a metric we are always looking to achieve. So, I am happy to see the same continuing to rise. Again, our goal is always to maximize the client's recovery. Each and every case has unique facts, unique amounts of insurance coverage available, and other factors that make it nearly impossible to compare cases to each other. The standard we hold ourselves to is one of continuous improvement. So, even slight upticks and increases in our overall recoveries are important to us.

One of our other goals is to provide the best client service experience in our industry. To make this possible, we want to hire the best staff available, and to structure our office in a fashion that we are easy to communicate with. Over the course of the last year, we made a few additions to our staff that we think greatly improve these items. We hired two senior level paralegals, who together, have over 70 years of experience in personal injury. Employees with this level of experience are hard to find, but they are significant investments in providing highly experienced and knowledgeable staff to help our attorneys in your case. We also redesigned how our attorney teams within the office are staffed and organized. Again, our goal is that each and every client actually has two lawyers working on their case. This includes myself, and either Todd or Amit. Underneath them is one of our senior paralegals, and under them is a case manager and an assistant. So there are at least 2 staff members and 2 attorneys working on each case at every step of your case through our office. Again, all of this is done to make sure your case gets the maximum amount of attention and detail. The system also acts as a check and balance system, with each layer overlooking the layer below. It is to make sure that all appropriate steps are taken at each step of your case, from intake through conclusion. Again, hiring this amount of staff and staff of this experience level requires a significant investment on my part. But the investment is worth it to meet our goal of providing the best client service experience we possibly can.

### QUE ENTRARON EN EFECTO EL 1 DE ENERO DE 2023

El 1 de enero de 2023, varias leyes entraron en vigor en el estado de Florida. Como es nuestra costumbre, en este articulo vamos a explicar algunas de ellas. Estas leyes fueron aprobadas por la legislatura estatal durante la sesión regular o durante la sesión especial para abordar varios problemas estatales como el seguro de propiedad y los daños causados por huracanes.

Entre ellos, la ley de Miya. Aprobada después de que Miya Marcano, de 19 años, fuera asesinada por un trabajador de mantenimiento en el complejo de apartamentos donde vivía, la ley requiere que los propietarios realicen investigaciones de antecedentes de todos los empleados.

En cuanto a la salud pública, SB 292 requiere que los recién nacidos sean examinados para detectar citomegalovirus si no pasan una prueba de audición. Esto ayudará en la detección temprana y el tratamiento del virus, que puede causar pérdida de audición en los bebés.

Para los conductores, SB 6-A ayudará a algunos floridanos a reducir sus facturas de peaje. El programa acreditará el 50% de los peajes a una cuenta si hay al menos 35 transacciones de peaje al mes.

EL HB7049, le esta dando la opción a las agencias del gobierno a publicar noticias o edictos legales en las paginas cibernéticas de la agencia, en vez de hacerlo en un periódico, como era el requisito anteriormente.

La ley SB2-A, que fue aprobada en la sección especial para tratar de solucionar lo de los seguros de las casas, prohíbe las asignaciones de beneficios que antes hacían los dueños para que los contratistas pueden recibir dinero directamente, sin tener que pasar por los dueños de la propiedad. Algo importante, esta prohibición entra en vigor a pólizas de seguro que han sido compradas después del 1 de enero del 2023.

También, para combatir intereses especiales, HB 7001 requerirá que los funcionarios que dejen de trabajar para el gobierno tienen que esperar seis años antes de que puedan comenzar a cabildear. Antes de la ley, el estado requería un período de espera de solo dos años. Es interesante como debido directamente a esta nueva ley de cabildeo, varios funcionarios del gobierno, incluyendo a jefes de agencias estatales y hasta jueces, renunciaron antes del 1 de enero, para evitar esperar 6 años antes que puedan cabildear.

Existen varias otras leyes nuevas, pero las ya explicadas son las principales y las cuales puede que afecten a ustedes directamente.

We also have seen the development of some specialty areas of practice within the firm. Our firm has always focused on auto accident and injury cases of all types. Over the last five years, we have expanded that focus to also include Wrongful Death and Catastrophic Injury cases of all type. In the last couple years though, and in particular this past year, we have started to develop niche practices in traumatic brain injury cases and in commercial trucking cases. Our attorneys and staff have all undertaken training sessions in traumatic brain injury cases, and the diagnosis and treatment of the same. This started a few years ago, but we are really starting to recognize and see more and more of these cases. Our familiarity with the presenting signs and symptoms allows us to help clients seek treatment and medical help for the same, thus providing proper diagnosis and documentation of the injury. Having the right evidence of this injury is crucial to presenting this type of claim. We did more of these cases then ever before in 2022. On the commercial trucking side, we are seeing more and more of these accidents as well. Our familiarity with the very specific types of evidence available on these trucks, has allowed us to move quickly in these cases, and to secure vital evidence that is crucial to proving these cases. We are also able to quickly recognize and identify the negligence of the trucking company and driver, from seeing similar fact patterns in previous cases. And finally, we have been successful in Court in keeping the trucking company in the case and pursing separate corporate negligence claims. These usually involve something the trucking company did improperly in hiring a driver or allowing them to drive the truck. The trucking companies always move to dismiss these claims. We have been successful in not having a single one dismissed yet. This maneuver increases the risk to the trucking company at trial, and opens the door to more discovery on the trucking company itself.




