After responding to calls for help in Central Florida, Ft. Myers, and Puerto Rico, where our firm contributed to help the victims of Hurricanes Fiona and Ian, we received a special request. It was from our friends and relatives in Cuba. Hurricane Ian devasted the zone of Pinar Del Rio.



Here is an important fact: contrary to our communities that might receive compensation from Insurance companies, or FEMA or Small Business administration loans, the folks in Cuba have no assistance at all. After the quick approval of our

boss, Michael T. Gibson, a group of missionaries got in contact with Jose Ballester, one of the ecclesiastical leaders in Cuba. He told us about the necessity for food, hygiene products and the fact that schools were destroyed in Pinar del Rio by the hurricane.

In the short time we organized this trip, we received contributions from several places, including: Juan Salgado from Urban Strategies who donated backpacks, Pastor Victor Arriaga and wife Lourdes Ramos from Ministerio Give who donated school supplies, Pastor Anibal Calderon and assistant Hector Rodriguez from Iglesia Cristiana Casa de Refugio De Zion, Iglesia de Dios Pentecostal MI of St. Cloud and Pastor Obed Rivera with mission's leader Hector and Minerva Cintron and Ladies leader Catherine Flores, and missionaries Felipe Encarnacion and Norma Santos, and other organizations such as CitiServe. Thank you to all of you, for your time and donations to help our folks in Cuba.

When we arrived at Habana, we were shocked by the flexibility and non-harassment treatment at the airport by government officials, something that is normal of customs in most foreign countries. We took 16 bags of luggage and they only opened one. We took food, clothes and school supplies, and nothing was taken away from us.

As soon as we arrived, we started the distribution of everything we were able to pack in our luggage. Rev. Ballester and his group took us where the help was most urgent, among them the area of Pinar Del Rio. This area depends of Tobacco and sugar cane production, both of them completely destroyed by the hurricane. Therefore, the source of income of this area was gone, and the need was clear. Besides taking food and small economical assistant to be distributed among some families, we have a special day for the kids in this affected area. Our firm provided cake, candies, and entertainment for them. In the middle of this suffering, we could see the joy on the kids' faces.

During our stay in Cuba, we also provided a business seminar. The government of Cuba has now given the opportunity to private citizens to have their own business, but some of them lack the basic knowledge to start a business. We rented a restaurant in old Habana, and had a full house of attendees. We gave orientation on some basic topics and universal tips to be considered while opening a new business.

I need to finish with this observation. The citizens in Cuba are brave with a lot of courage. It does not matter Continues on page 2.

### viaje misionero humanitario A CUBA DESPUÉS DEL HURACÁN IAN

Después de responder a las llamadas de ayuda en Florida Central, Ft. Myers y Puerto Rico, donde la oficina legal contribuyó a ayudar a las víctimas de los huracanes Fiona e Ian, recibimos una solicitud especial. Era de nuestros amigos y parientes en Cuba. El huracán IAN devastó la zona de Pinar del Río.

Aquí hay un hecho importante: Contrario a nuestras comunidades que podrían recibir compensación de las compañías de seguros, o FEMA o préstamos de la administración de pequeñas empresas, la gente en CUBA tiene muy limitada asistencia. Después de la rápida aprobación de nuestro jefe, Michael T.

Gibson, un grupo de misioneros se puso en contacto con José Ballester, uno de los líderes eclesiásticos en Cuba. Nos habló de la necesidad de alimentos, productos de higiene y del hecho de que las escuelas fueron destruidas en Pinar del Río por el huracán.

Necesito hacer una pausa aquí – es tan poco tiempo que organizamos este viaje, recibimos contribuciones de varios lugares, individuos y instituciones como Juan Salgado de Urban Strategies que donó mochilas, el pastor Víctor Arriaga y su esposa Lourdes Ramos de Ministerio Give con donaciones de útiles escolares, el pastor Aníbal Calderón y el asistente Héctor Rodríguez de la Iglesia Cristiana Casa de Refugio De Sion, Iglesia de Dios Pentecostal MI de St. Cloud y pastor Obed Rivera con los líderes de misiones Héctor y Minerva Cintrón y la líder de Damas Catherine Flores, y los misioneros Felipe Encarnación y Norma Santos, y otras organizaciones como CITISERVE por su tiempo, contribuciones y donaciones para ayudar a nuestra gente en CUBA.

Cuando llegamos a La Habana, nos sorprendió la flexibilidad y el trato no acosador en el aeropuerto por parte de los funcionarios del gobierno, algo que es normal de las aduanas en la mayoría de los países extranjeros. Llevamos 16 maletas y solo abrieron una. Llevamos comida, ropa y útiles escolares, y no nos quitaron nada. Contrario a lo que algunos medios noticiosos nos informan sobre Cuba, fuimos recibidos con gran hospitalidad.

Tan pronto como llegamos, comenzamos la distribución de todo lo que pudimos empacar en nuestro equipaje. Ballester y su grupo nos llevaron donde la ayuda era más necesaria, entre ellos el área de Pinar del Río. Esta zona depende de la producción de tabaco y caña de azúcar, ambas completamente destruidas por el huracán. Por lo tanto, la fuente de ingresos de esta área había desaparecido, y la necesidad era clara. Además de llevar comida y una pequeña asistencia económica para ser distribuido entre algunas familias, tuvimos un día especial para los niños de esta zona afectada. El bufete de abogados les proporcionó pasteles, dulces y entretenimiento. En medio de este sufrimiento, pudimos ver la alegría en los rostros de los niños.

Durante nuestra estancia en Cuba, también ofrecimos un seminario para negocios. El gobierno de Cuba ahora otorga la oportunidad a los ciudadanos privados de tener su propio negocio, pero algunos de ellos carecen de los conocimientos básicos para iniciar un negocio. Alquilamos un restaurante en la Habana Vieja, con casa llena, dimos orientación de algunos temas básicos y consejos universales para ser considerados al abrir un nuevo negocio.

Necesito terminar con esta observación. Los ciudadanos en Cuba son valientes con mucha intrepidez. No importa cuál sea la crisis, están listos. De la misma manera que enfrentamos una escasez de alimentos y dificultades de inflación en Estados Unidos, Cuba está teniendo lo mismo que el resto del mundo. Sin embargo, están manejando esta crisis con una capacidad perdurable y listos para el desafío que se avecina. Por supuesto, su fe en Dios y saber que Dios está en control, tienen mucho peso en esta aptitud.



Como resultado directo de este viaje, hemos desarrollado relaciones estratégicas que esperamos faciliten y agilicen a cualquier asistencia adicional a esta Isla, a solo 90 millas de nuestra costa. QUE DIOS BENDIGA A CUBA Y A SUS CIUDADANOS.
