
As soon as the bill was introduced, that fear and panic consumed me. But not too long into the process, and after studying the bill in depth, I realized that this law change would not be the end of me, or our firm. In fact, the more I read and studied, the more I came to understand how all this law did was basically give the insurance companies more excuses and more reasons to not pay and to deny rightful compensation to injury victims. Well, I have

been fighting that for 20 years. And nothing they passed is anything I have not seen before.

Once I realized this, I went from panic to planning. Within weeks of the law passing, I rolled out an entire set of new systems and strategies, that we have already been deploying for months. Almost all of them have been successful thus far. I used this as an opportunity to really dig into the firm and its systems. I studied what we did really well, and I tweaked a few things to accommodate the law changes. Having worked on this for a number of months this year, and having reviewed these systems continuously throughout the year, I exit this year feeling very confident that our clients and our firm are in good position to handle and successfully combat any of the new, legislatively gifted tactics the insurance companies try to use against us and our clients.

Other than that, it was another great year for our firm. 2024 will mark our 15th anniversary. In a lot of ways, it still feels like we just opened the place yesterday. And in others, as time goes on, I find myself drawing more and more examples from our

15-year history, then my career that proceeded it. I probably don't need to say this, but the personal injury business is ruthlessly competitive.
