I cannot believe it is time for the holidays already, and that another year has come and gone. For so many, the holidays mean spending time with loved ones, shopping for the perfect gifts, and decorating. But along with these fun activities, I want to suggest you give your loved ones and you something they will always welcome – Peace of mind by doing a legal check-up.

Planning for one's legal needs is a lot like going to a dentist – Almost no one gets excited about doing the same, but is necessary. You should go to a doctor at least once a year for a physical check-up to make sure your body is in good health. Shouldn't you at least do the same for your legal and financial health? Family situations and financial situations can change from year to year. That is why I think the end of the year is the perfect time to assess your family's personal legal and financial health and take the appropriate actions to give your family that oh-so-valuable peace of mind heading into the New Year.

So what does a good legal health check-up entail? You should be sure to address the following:

1) Estate Planning – No one wants to think about losing a loved one or what the plan is when a spouse or parent passes away. However, not doing so could leave the surviving loved one in a very serious and hazardous legal situation. Having a Will and an Estate Plan can ensure that your family will be protected financially in case of an unexpected loss. It also minimizes inter-family disputes about who is entitled to what. If you are a parent, you absolutely need a basic Will and Estate Plan to make clear who will have custody and responsibility for your children in the event of your death. Most simple Estate Plans are not that expensive, especially given the legal protections and peace of mind they provide. In addition to a Will, make sure you have a Durable Power of Attorney. This will help protect your wishes with regards to medical care in the event you are incapacitated. This can relieve your family of one of the most stressful and difficult decisions a loved one could make.

2) Insurance – In my practice, I cannot tell you how many times I have had to turn down a case because there was no insurance to be found. Usually that means the at-fault driver didn't have bodily injury coverage, and our client did not have Uninsured Motorist Coverage (what we call "UM"). UM is a must-have coverage for all drivers in Florida. Close to 50% of all drivers do not carry Bodily Injury, meaning that without UM, there is a 1 in 2 chance that a bad accident will leave you with no coverage and no responsible party. That is why UM is so vitally important for you and your family to have. If you are renewing your car insurance, make sure you add UM to your policy, and add as much as you can afford to. Here is a tip, as well – Most car insurance agents will never tell you about this coverage or will tell you don't need it. That is 100% wrong and incorrect. I look at and review approximately 1300 car accident cases a year – I know my stuff and I am telling you, buying UM is just as important as buying any other form of insurance for your family. If you have UM coverage, it should appear on your insurance card and policy. If you do not see the same, check your policy to see if the insurance company had you sign a rejection form, rejecting this coverage. If so, you should contact your agent, and advise them that you wish to add UM, and again, purchase as much of this coverage as you can afford.

- 3) Life Insurance In addition to UM on your auto policy, take the time to look into Life Insurance. Life Insurance, like a good Estate Plan or Will, ensures that your family can cover the loss of your financial contribution and has a pool of money to move forward in life with. Term life insurance policies are relatively inexpensive and provide great bang for the buck. If you don't have life insurance, they offer a great way to start. If you have Life Insurance already do you have enough? Again, year to year, circumstances can change. Review your policy and see if you need additional coverage or maybe you need a Whole Life Policy, which offers even greater financial protections and returns. In addition to providing your family with a safety net, life insurance policies can also serve as an investment vehicle. It is a way to make decent returns on the money invested, without risking the funds in the stock market. Advice differs as to how much life insurance one should carry. But just like with UM auto insurance, I would recommend purchasing as much as you can comfortably afford.
- 4) Homeowners Insurance this is a particularly controversial topic in our State at this time. The impacts of several significant Hurricanes have limited the number of options available in the State of Florida, and those carriers writing coverage are charging higher premiums for doing so. The Legislature addressed this issue last December by passing a number of reforms and restrictions on lawsuits against Homeowner's insurance companies. One year later, almost every Floridian is still seeing significant price increases in their Homeowners insurance pre

miums. Furthermore, more than half of the State has been forced to take out coverage through Citizens Insurance, which is the State-run carrier. The State is now trying to force a large number of Citizens' insureds to switch to other carriers. When it comes to homeowners coverage, I would highly recommend that you thoroughly review any policy offered to you. Over the years, carriers have been carving out coverage exclusions, and drastically limiting their claims liability by changing the language in the policy itself. For example, all homeowners policies used to cover mold or mildew exposure, or would provide coverage and a defense to you if a dog on your property bit someone. Not anymore. Both of these instances are now usually excluded within every basic homeowners' insurance policy. You would have to purchase a 'rider,' or additional coverage on the policy to have coverage for these events. And if you do not ask for them, you will not ever be told this. Read your Homeowner's policy carefully, and be sure to ask your agent questions if you believe the policy does not provide you coverage for a specific instance.

5) Incorporation/LLC Protection – if you have started a business and/or are planning to in the New Year, make sure you get your business properly incorporated. This is vital to protecting your personal assets, in case of a lawsuit. Incorporation is pretty easy to do on your own at www.sunbiz.org. You should always consider using an attorney or at least getting a consult to make sure you are doing it correct.

Other areas to consider are child support/visitation and/or alimony obligations, if circumstances have changed.

The holidays and the end of the year are busy times for families and businesses. There never is a great time to give your household a legal checkup and there certainly are more fun things to do during the holidays. However, you will feel a lot better, sitting at your holiday dinner, knowing that you and your family are protected for the New Year and beyond.
