nuevas leyes en la Florida

En el pasado artículo, comentamos sobre una nueva ley firmada por El gobernador de la Florida, Ron Desantis, que impide a menores de 16 años a que tengan cuentas en las redes sociales. Como fue explicado, esta ley impedirá que los niños menores de 16 años abran cuentas en las redes sociales, aunque permitiría a los padres dar su consentimiento para que los niños de 14 y 15 años tengan cuentas.

Existe otras leyes que a partir del 1 de Julio 2024 entraron en vigor, que son la HB 931 y HB 131, con referencia a los Capellanes.

Primeramente, la ley HB 931, les otorga a las escuelas la autoridad de permitir que capellanes voluntarios vayan al campus escolar y ofrezcan apoyo de orientación a los estudiantes, con el consentimiento de los padres. Algo importante - primeramente, tienen que consultar con la junta escolar de su distrito para seguir el protocolo y requisitos establecidos para poder ser parte del cuerpo de capellanes voluntarios en las escuelas públicas ya que Los capellanes serán asignados por la junta escolar del distrito o la junta directiva de la escuela.

La otra ley es la HB 1317, que autoriza a los distritos escolares a permitir las organizaciones cívicas y patrióticas y a sus representantes que hablen con los estudiantes, distribuyan ciertos materiales. También para que brinden oportunidades a ciertas exhibiciones relacionadas con las organizaciones. Por otro lado, exige a algunos distritos escolares que proporcionen fecha y hora para que se den dichas actividades y que autoricen a las organizaciones al acceso a los edificios y propiedades escolares en determinadas circunstancias. Nota importante: En algunos distritos escolares, los cadetes cristianos podrán ser permitidos a tener acceso bajo esta nueva ley. Favor de consultar con su junta escolar para verificar si cualifican.

*** Precaución ***

Instamos a los ministros, capellanes y líderes eclesiásticos a monitorear la aprobación de las organizaciones y de capellanes en sus distritos escolares debido a que existen grandes preocupaciones sobre el acceso a las escuelas de grupos controvertidos, como aquellos que practican el satanismo. Estemos en alerta, ya que estos grupos pueden aprovechar estas nuevas leyes para entrar en las escuelas públicas.

Estas leyes entraron en vigor hace unas semanas, en el 1 de julio del 2024. Que Dios te continue bendiciendo.

Tahiti — your summer olympics cohost



France is hosting the Summer 2024 Olympics in all their glory — well, maybe not all. Tahiti will be the site of the surfing competitions.

Tahiti is the main island of French Polynesia, an assemblage of 118 islands and atolls covering over 2 million square miles of ocean territory in the South Pacific. Tahiti became a French protectorate in 1842; all of French Polynesia followed suit in 1880. French Polynesia was designated a French overseas territory in 1946 and then granted autonomy in 1977.

French Polynesians are French citizens who have the right to vote in local, French national, and European elections. The president of France is French Polynesia's head of state and is represented by a high commissioner. This strong Tahitian–French connection led to Olympic collaboration.

Tahiti is famous for its beautiful black sand beaches; lush, mountainous landscapes; pristine waters; vibrant coral reefs; gourmet vanilla beans; and pearl farming. It's also home to the most challenging waves in the surfing world, especially at Teahupo'o. Tahiti is world-renowned for hosting spectacular surfing competitions; France is not.

Many Tahitians were in favor of hosting Olympic surfing: reaping economic benefits, showing off their little corner of the world, etc. But many were opposed, as their deep reverence for their natural surroundings was of paramount importance. In response to concerns, 98% of Olympic housing will take place either in locals' homes or on a nearby cruise ship. A judging tower anchored in the coral reef was scaled back to minimize damage, as sea life and Tahitians' livelihoods are at stake.

The siren call of the Olympics is tough to resist. Tahiti's hope is that their limited role will lead to value without the regret.
